Dear Parents/Carers,

Re: Seesaw – online sharing journal

This half term, Sycamore 1 and Willow 2 will be trialling the use of Seesaw for Key Stage 2.

We are keen to promote children taking ownership of sharing their learning. Seesaw (<http://seesaw.me>) is a secure online journal (similar to Tapestry which is used in EYFS) where students can document and reflect on what they are learning in class. Your child will be able to independently add photos, videos, worksheets, drawings and voice recordings to their Seesaw journal.

We can share this privately with you and other family members so you can view and comment on work throughout the school year. This gives parents and carers a greater insight into a Key Stage 2 day and allows the children to show off any learning they are proud of.

In order for your child to use Seesaw, the app needs your child's name in order to be able to associate work like their photos, videos or voice recordings with their account. Seesaw only uses this information to provide the service and doesn't advertise in Seesaw, create profiles of students, or share or sell your child's personal information or journal content. 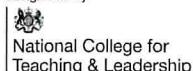
