

Attendance Monitoring

Your child's attendance level will be measured against the following criteria and support offered as appropriate.

96 – 100% Very Good / Excellent Attendance

Excellent achievement - on track to achieve social and academic success.

92 - 95.9% Below Expectation

Concern - Your child's absence will be monitored on a daily basis. A call home will be made to query absence if appropriate. Stage 1 Letter of Concern issued to offer guidance and support and to encourage levels to improve.

Support options can often ensure issues are resolved quickly enabling attendance levels to remain high.

Below 92% Unsatisfactory Level

Serious Concern

At risk of persistent absence from school

Stage 2 Letter of Concern issued. Referral to Warwickshire Attendance Service will be considered. Parents/carers will be invited to attend a meeting in school with College Leader and Attendance Officer, to discuss strategies to improve attendance. An attendance target will be set.

Below 90% Attendance

Persistent Absence from school

Medical evidence will be required to support absence from school for levels below 90%.

Falling attendance levels without agreement of school will be referred to W.C.C - Warwickshire Attendance Service (WAS). A 50 day Legal Attendance Target may be set. Failure of a target may lead to a fixed penalty notice being issued to parents / carers.

Attendance at school is our shared responsibility to ensure **every child** makes the very most of their education and opportunities on offer.

Please support us by sending your child into school every day possible.

Before you keep your child off school

A large proportion of student absence is due to coughs, colds, headaches, minor complaints & injuries. We would ask you to consider sending in a note excusing your child from certain activities if needed, or allowing appropriate medication to be taken rather than keeping them off school for the whole day and missing out on **five periods** of academic learning per day.

Please contact Attendance Support Room staff in school for all medical related issues. Staff will ensure they keep in touch should your child be too unwell to stay in school. A phone call home will be made by staff to discuss any areas of concern.

Holiday Requests and Leave of Absence

Children are at school for 190 days each year. Leaving 175 days left for other activities.

In line with DfE guidelines Leave of Absence applications will be considered on a case by case basis and permission will be granted in *exceptional cases only*. We will not authorise absence requests for birthdays, treats etc. during term time. **Unauthorised absence** taken will be referred to W.C.C for consideration of a £120 fixed penalty notice per parent/carer.

What should you do

Ensure your child attends school :-

EVERY DAY & ON TIME

Report any absence including medical appointments or reasons for late entry to school by using the 24hour **Absence Line 01789 209296** before 8.45a.m on **each day** of absence. For longer term absence please call the **Attendance Officer direct on 01789 416621.**

Please ensure medical & dental appointments are made outside of school time where possible. **We would prefer your child to be in school for 8.45a.m** and released from lessons to attend an appointment if necessary.

Contact us immediately if you are concerned about your child's attendance at school.

Recognise, praise and reward good attendance in school. Please support the school to ensure punctuality and attendance are excellent.

Communicate with your child's form tutor or college leader or subject teachers with any concerns however small you may feel this is.

Monitor attendance levels via MCAS regularly.

What your child should do

Aim for 100% attendance every week.

Be on time to school for a prompt **8.45a.m start** and be on time to all lessons.

Let their tutor know if there are problems affecting their attendance at school.

Take personal responsibility for ensuring excellent attendance levels are maintained and monitor this via Bromcom.

What we will do!

We will monitor your child's attendance on a daily basis. We will send a Group Call absence alert message whenever your child fails to register for A.M or P.M roll call.

We will support and guide you to ensure excellent attendance levels are maintained in school, to ensure your child reaches their full social and academic potential. We will impose sanctions on students who are late to school or truant.

We will refer to W.C.C - Warwickshire Attendance Service (WAS) for support when needed. This may result in a 50 day Legal Attendance Target being issued.

The Legal Position

Under section 7 of the Education Act 1996 parents & carers are under a positive duty, to ensure that a child receives an efficient and full time education either by regular attendance at school or otherwise. ***The law makes it clear that only school can authorise an absence and has no obligation to do so.*** This applies even when we have been notified of the reason for absence.

Globally most Muslims do not practice FGM, it is neither a requirement or a `Sunna` in Islam. We are aware that some UK communities are more at risk than others. FGM is illegal in the UK and considered to be child abuse. As such we will follow appropriate safeguarding procedure whenever FGM is a possible reason for absence from school or removal from roll.

The Bigger picture...

There is a clear and researched link between attendance and achievement in school.

Whenever a young person misses school through illness, holiday or truancy they miss out on important learning opportunities.

It is extremely difficult to catch up on work missed. Social and academic development can be negatively affected.

95% attendance = **10 days missed per year**

90% attendance = 2 days missed per month
= 10 lessons missed per month
= **20 days missed per year**

80% attendance = 1 full day absence per week
= **4 days missed per month**
= 20 lessons missed per month
= **38 days missed per year**
