



## **Consultation on the Admissions Policy 2016-17**

### **Frequently Asked Questions (FAQs)**

- **The Governing Body are consulting on two changes to the Admissions Policy, will the two changes be considered separately?**

Yes, the two proposed changes to the Admissions Policy will be considered separately. For example one change may be agreed, and the other not agreed. Only the agreed change will be amended in the policy.

- **Who is being consulted on within the Consultation process?**

- **What is the overall process for the Consultation?**

The Consultation commenced on 2 January 2015, and will run until midnight on 28 February 2015.

On conclusion of the Consultation on Saturday 28 February, all responses received will be collated and presented to the Governing Body in early March 2015 for full consideration. The outcome of the Consultation will then be notified to all parents by the end of March 2015 and the full report will be posted on the Academy's website.

- **Will there be updates available throughout the Consultation?**

The Frequently Asked Questions (FAQ) document will be updated throughout the Consultation. Please note the FAQ will not detail the responses received to the Consultation, but will address specific questions with regards to the process. The purpose of the Consultation is to receive feedback on the proposed changes, and for the responses to then be collated and presented to the Governing Body for full consideration. There will be no further updates throughout the Consultation period, outside of the FAQs being updated.

- **When will the outcome of the Consultation be communicated?**

The outcome of the Consultation will be communicated by the end of March 2015 and the full Consultation report will be posted on the Academy's website.

- **Can the outcome of the Consultation be communicated earlier than the end of March 2015, as this will be after the date when offers need to be accepted?**

The Governing Body will endeavour to provide an outcome as soon as possible. The timescale for the end of March 2015 has been given, in order that the Governing Body can fully review all responses and to ensure a fully considered outcome is reached.
